An application under Section(s) 230 to 232 of the Companies Act, 2013 read with the Companies (Compromises, Arrangements and Amalgamations) Rules, 2016 was presented before the Hon'ble National Company Law Tribunal, Kolkata Bench ('Hon'ble Tribunal' or 'NCLT') for sanctioning the Scheme of Amalgamation amongst TRF Limited ('Transferor Company' or 'Company') and Tata Steel Limited ('Transferee Company') and their respective shareholders ('Scheme').

This is to inform that the Hon'ble Tribunal vide Order dated September 22, 2023, rea with the Corrigendum Order dated September 29, 2023 passed in the Company Scheme Application No. C.A.(CAA) No.106/KB/2023 ('Order'), has directed, interalia, that a meeting of the Equity Shareholders of the Transferor Company be convened and held on Tuesday, November 7, 2023 through video-conferencing ("VC") or other audio-visual means ("OAVM") ("Meeting") to consider and if thought fit, approve, with or without modifications, the Scheme.
