Sub: Disclosure of continuing event or information under Regulation 30(4) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations')

This is further to our disclosure dated August 14, 2023 ('Disclosure') on the above-mentioned subject.

In the said disclosure, TRF Limited ('Company') had, *inter alia*, disclosed details of service tax litigations, pending appeals before the Customs Excise & Service Appellate Tribunal ('CESTAT'), Kolkata; contesting the demand of Service Tax for the purpose of computing Service Tax liability under the Works Contract composition scheme amounting to ₹31 lakhs. The litigations/disputes pertains to June 2013 to March 2016.

We wish to inform you that, on April 10, 2024, the Company has received Final Order from the Customs, Excise & Service Tax Appellate Tribunal, Kolkata, ('Tribunal') on all the three appeals filed by the Company, whereby the Tribunal has set aside the Demand Orders of Additional Commissioner of Central Excise & Service Tax, Jamshedpur and Assistant Commissioner of Central Excise & Service Tax, Division-IV, Jamshedpur.
