# ANNUAL REPORT OF JOINT COUNCIL 2011-2012

#### MEETINGS:

All meetings of the Joint Council were held as scheduled during the year.

#### SAFETY:

- Achieved zero lost time accident
- Launch of theme based safety campaign to enhance focus on critical safety issues like fire safety, hand injury, etc.
- Safety for community awareness programmes conducted in colony and nearby community

### PERFORMANCE & GROWTH:

- All time high consolidated turnover of Rs. 1327 Cr surpassing the previous best of Rs 1114 Cr in 2010-11, an increase of 19%
- All time high turnover of BMHS Rs.536 Cr. surpassing its previous best of Rs. 475 Cr. in 2010-11, an increase of 13%
- All time high Works production Rs.280 Cr. surpassing its previous best of Rs. 249 Cr. in 2010-11, an increase of 12%
- Record production of P&YE products of Rs 61 Cr, an increase of 20% over last financial year
- BMHS achieved Rs 150 Cr turnover in NTPC, Vindhaychal project (ABP target of Rs 130 Cr)
- BMHS achieved collection of Rs 100 Cr in a month for the second time in March 2012
- ♦ Successfully conducted PG test for NSPCL, Bhilai and BHEL, Amarkantak
- All time high structural erection of 1000 tonnes at Mouda site in January 2012
- ♦ Achieved 2400 TPH load trial at Jhajjhar site, Aravali Power Company
- ♦ Successfully demonstrated 21 tips/hour by Wagon Tippler at Bhilai site
- Record production of Idlers of Rs 40 Cr; an increase of over 43% over last financial year
- Record production of Pulleys of Rs 19 Cr, an increase of 75% over last financial year
- Bagged largest order for operation and maintenance of coal handling plant of Parichha Thermal Power plant
- Operation and maintenance contract of Tata Power, Trombay was renewed based on performance – plant availability has been maintained consistently above 95%
- 100% acquisition of York Transport Equipment (Asia) Pte, Singapore and Dutch Lanka Trailer Manufacturers Limited, Sri Lanka
- Collaboration with Schade Lagertechnik Gmb, Germany for exclusive right to manufacture and market high capacity yard equipment in India
- TRF was awarded "Winner of Tekla Structures Model Competition in Tekla India User Meet-2012"

#### COST REDUCTION:

Cost Reduction of Rs 16.50 Cr achieved through various initiatives

#### NEW FACILITIES ADDED:

♦ Addition of Bay#7 (20 mts by 240 mts) which became fully operational with two EOT cranes

#### ENGINEERING and R&D:

Registration of R&D facility by Department of Science and Technology (DSIR)



- Implementation of 3D modeling and FEA software for designing of equipment
- Used CAE for optimisation of weight and power of equipment, analyzing failures and remedial measures
- Innovative mounting of roof drilling machine in Side Discharge Loader for mining

#### QUALITY:

- Initiated Process Control in Vendor Quality activities
- Introduced process audit on shop floor

#### SUGGESTIONS:

Rs 46.12 lakhs was saved through suggestions as against Rs35.00 lakhs in 2010-11

#### EMPLOYEE INVOLVEMENT:

- 84% employees participated in 65 Quality Circles
- 80 new CFT projects were taken up during the year. 37 CFT projects were closed
- 10 Knowledge Communities were functional. 75 Knowledge sessions were held
- A new portal on Knowledge Management was launched for sharing knowledge across the organisation

## **COMMUNICATIONS:**

- Introduced theme based messaging on monthly basis through 'Convergence', active directorydesktop and pay slips for enhanced focus on important issues
- Enhanced safety communication and displays in Works
- Installed TV in canteen for mass communication

#### TRAINING & MANPOWER DEVELOPMENT:

- Over 100 training programmes were conducted which were attended by 2046 participants enabling the company to achieve 5.92 training man days per employee
- Training programmes focused on building manufacturing, engineering and project management capabilities
- 178 employees were covered under 4Q skill development programme resulting in increase in skill index from 0.69 to 0.71
- 31 trainees were absorbed after screening trade tests
- 68 graded employees were promoted
- 48 graded trainees inducted underwent fundamental training in different trades viz. fitting, machining, welding, mechanical maintenance & electrical

#### WELFARE:

- 96 children of employees were given Education Assistance from Welfare Fund of the Joint Council
- Rs. 3.00 lakhs was granted as loan to 15 employees for the purpose of higher education and marriage.
- 24 employees' children granted scholarship for higher studies
- 34 employees were given retirement gifts

- 'Sports Bonanza' and 'Battlefield-22Yards' were conducted involving employees across the Company
- Our chess team secured third position in the inter-company tournament. TRF Teams participated in numerous inter-company sports events

## COMMUNITY INITIATIVES:

- MD, TRF was elected Deputy Chairman of Confederation of Indian Industries, Eastern Region
- Employee volunteerism initiative, 'Main Hoon Na' was launched
- 62 apprentices were given one-year training in trades like fitter, welder, electrician and machinist to enhance their employability
- More than 300 engineering and management students were provided internship/summer training
- In addition to the ongoing programmes, which include "Akshar and Astitva", the Company in association with TRF Ladies Association conducted the following:
  - 78 children administered Pulse Polio drops
  - 150 free cataract operations, with IOL implants, were performed
  - 268 units of blood collected in voluntary blood donation camps
  - 849 patients treated in the weekly free health clinics in TRF Colony
  - 166 children were covered in the preventive health check-up camps
  - 42 National Association for Blind (NAB) students were covered under health support programme
  - Provided 10, 000 litres/day of potable water to residents of Birsanagar 'bastee' through rain water harvesting. 3.65 million litres of water has been provided in the financial year
  - Distribution of solar lanterns to members of key community
  - Financial contribution to various cultural, social and professional bodies
  - Expansion of 'Akshar' school capacity of accommodate 80 children
